 It is now 40 years since Te Hīnota Whānui / the General Synod established Te Kōmihana mō te Kaupapa Tikanga Rua mō te Tiriti o Waitangi / The Bicultural Commission on the Treaty of Waitangi / Te Tiriti o Waitangi;

- 2. It has been more than 30 years since Te Pouhere / The Constitution was adopted by Te Hīnota Whānui / The General Synod in 1992, to give effect to the principles of Treaty Partnership and Bicultural Development within Mihinare / Anglican ecclesiology, as outlined in Te Kōmihana's report; and
