Opening Prayer and Reflection

The General Synod / Te Hīnota Whānui in Wānanga on Mana Wāhine – Ven Ruihana Paenga, Bishop Ana Fletcher, Ms Colleen Kaye, and Ms Bolivia Smith.

Synod / Hīnota reconvened at 11.00am with Archbishop Don Tamihere in the Chair.

There were no further Apologies.

Notices

Archbishop Don Tamihere welcomed Ms Margaret Bearsley from Anglican Financial Care, and acknowledged members of the Religious Orders who were praying with and for the Synod / te Hīnota.

At the end of the session before dinner, nominations close, ready for elections tomorrow.

There were no Petitions, further Reports, Motions of leave to introduce Bills, or Notice of Motions.

Motion #9

50th Anniversary of the Ordination of Women

Mover: Ms Jessica Hughes **Seconder:** The Rev'd Dr Anne van Gend

That this General Synod / te Hīnota Whānui

- 1. Notes that the 50th anniversary of the first ordination of women in this Provincial Church will occur in 2027;
- 2. Asks the General Synod Standing Committee to establish and resource a representative small working group to plan appropriate and significant celebrations for this occasion; and
- 3. Invites such a small working group to propose plans and budget for such celebrations to be included in the finance bill to the meeting of the General Synod / te Hīnota Whānui in 2026.

In moving the motion, the Mover sought leave to include an amendment:

 Add the words "to the priesthood" in clause 1 directly after the word women which was agreed.

Following debate, a Caucus by Gender was called. Although there is no provision in the Standing Orders to caucus this way, the Chair put it to the floor of Synod / Hīnota if they were happy to caucus in that way, it was agreed to proceed in that manner.

Synod / Hīnota in Gender caucus to lunch at 12.50pm.

Synod / Hīnota reconvened after lunch break at 1.50pm.

The Chair called for report back from caucuses.

Men's caucus discussed women's leadership. A statement of repentance was delivered verbally to the Synod / te Hīnota by the Rev'd Canon Michael Wallace.

The men's caucus then sang a waiata in support of their statement.

The Ven Ruihana Paenga reported from the **women's caucus** and sought leave to introduce a Motion without notice tomorrow that encompasses the report back from the two caucuses. **Agreed unanimously.**

It was agreed to introduce a consequential second amendment to Motion #9.

Amendment:

Amend clause 2 to delete the words 'establish and' and to replace the words 'a representative small working group' with the words 'the Council for Anglican Women's Studies,' and consequentially amend clause 3 by replacing the words 'Invites such a small working group,' with the words 'Resources the Council for Anglican Women's Studies.'

Motion # 9 as amended

50th Anniversary of the Ordination of Women

Mover: Ms Jessica Hughes Seconder: The Rev'd Dr Anne van Gend

That this General Synod / te Hīnota Whānui

- 1. Notes that the 50th anniversary of the first ordination of women to the priesthood in this Provincial Church will occur in 2027;
- 2. Asks the General Synod Standing Committee to resource the Council for Anglican Women's Studies to plan appropriate and significant celebrations for this occasion; and
- 3. Resources the Council for Anglican Women's Studies to propose plans and budget for such celebrations to be included in the Finance Bill to the meeting of the General Synod / te Hīnota Whānui in 2026.

Motion # 5

Anglican Church support of Christian KiwiSaver Scheme

Mover: The Most Rev'd Philip Richardson **Seconder:** The Rev'd Canon Isaac Beach

That this General Synod / te Hīnota Whānui 2024:

1. **Notes** that The New Zealand Anglican Church Pension Board, trading as Anglican Financial Care/ Te Maru Mihinare (AFC), is the Issuer and Manager of Aotearoa New Zealand's only KiwiSaver Scheme that is based on Christian membership and values, which is called the Christian KiwiSaver Scheme (CKS) formerly called Koinonia KiwiSaver Scheme;

- Notes that CKS was established in 2007 when KiwiSaver was introduced as a savings product in Aotearoa New Zealand, and that CKS is restricted to those with an active Christian faith, immediate family members of those with an active Christian faith, and employees of Christian organisations whose primary activities are Christian mission or ministry.
- 3. **Notes** that AFC applies its Ethical Investment Policy to all its funds, ensuring that its investments are made and are maintained in accordance with Christian values.
- 4. Notes that CKS consistently outperforms its benchmarks, and while its fees are higher than average, they are not significantly out of line with the market, and that the larger CKS grows the better economies of scale it can achieve to pass on those savings to members;
- 5. **Notes** that employers in Christian organisations whose primary activities are Christian mission or ministry can select CKS to be their employer chosen KiwiSaver scheme for their employees, so that employees who will be auto-enrolled into KiwiSaver or opt into KiwiSaver, and do not choose their own scheme, will be enrolled in CKS; and
- 6. **Agrees** to strongly encourage all Anglican Church-related employers to apply to AFC to have CKS as their employer chosen KiwiSaver scheme.

Amendment:

Point 6 – add 'within Aotearoa New Zealand' after the word 'employers'.
